General Regulations:

The Ice Dance Cup-Vienna 2005 is an International Competition and will be conducted in accordance to the ISU Constitution and General Regulations and ISU Special Regulations for Ice Dancing, all 2004 edition, as well as all pertinent ISU Communications.

Entries:

All invited Nations, which are members of I.S.U., are invited to take part at the competition. ISU Members must enter their couples and their substitutes on the official entry form.

Deadline: The deadline will be **October 30th, 2005** and must be sent simultaneously

The maximum number of couples is in principal limited to 12 in each group.

Entries of Team Leaders and Others

Official entries of Team Leaders, Team Officials and Coaches will be accepted. However, the Organizing Committee will not cover any costs related to these persons. Accreditation will be provided to those who are officially accepted by the Organizing Committee.

The names of Team Leaders, Assistant Team Leaders, Team Officials, Team Medical Staff, Coaches and Chaperones must be listed on the General Entry Form "Composition of Delegation". Judges and Judges Partners or relatives are to be listed on a separate form.

Couples must turn in to the Organizing Committee together with the entry forms the "Program Content Sheet".

Category of Pre Novices:

Compulsory Dances: Group 1: Fourteen Step, European Waltz

Free Dance: to be constructed in accordance with ISU Rules for Pre Novices, Vocal music is not permitted!

Category of Novices: Compulsory Dances: Group 1: Rocker Foxtrott, Paso Doble

Free Dance: to be constructed in accordance with Rule 510 with the following modification: 3 min. (+/- 10 seconds), vocal music is not permitted (see also ISU Communication 1331)

Age Requirements:

By July 1st preceding the event.

a) Must not have reached fifteen (15) for girls and seventeen (17) for boys.

b) Neither partner may be younger than ten (10)

Marking and Determination of Results:

After having determined the result in each part of the Competition, the placing obtained by each Ice Dance couple, in each part of the Competition – Communication 1331 ISU (new System)

Category of Juniors: COMPULSORY DANCE: Quickstep

The number of sequences shall be as per Rule 540 § 1.

ORIGINAL DANCE: ISU 2005/2006 2 minutes 30 seconds (+/- 10 sec)

FREE DANCE: 3 minutes (+/- 10 seconds)

Category of Seniors: COMPULSORY DANCE: Tango Romantica

ORIGINAL DANCE: ISU Latin Combination 2 minutes 30 seconds (+/- 10 sec)

FREE DANCE: Rule 510 4 minutes (+/- 10 seconds)

Marking and Determination of Results:

An Ice Dance event shall be marked in accordance with Rule 525.527 (new System)

Judges: Each invited **Member** which has entered can enter one International Judge, or Judge for **ISU**. The organizer reserves the right to select the Judges. Written confirmation will be sent to each **Member** by **November 10th, 2005** via fax or mail.

Full board expenses will be covered by the organizer from lunch on November 29th, 2005 until dinner on **December 2nd 2005**.

Deadline for entries: All entries (couples, judges, team leaders, coaches, other attendants) are expected **to be sent by registered mail and by fax** to the organizers address not later than **Oct. 30th, 2005**.

Music: Music will be reproduced from cassette player with normal speed or CD. Cassettes or CDs must be labelled with names of competitors, club and category in which they enter. Cassettes or CDs must be delivered immediately after team's arrival to Organizing Committee. **No Mini-Discs!**

Accommodation: All participants, except drawn judges, have to book and to pay the accommodation by themselves. The Hotel AUSTRO TREND is 2 minutes walk distance from the ice rink.

Catering: Meals for all skaters, coaches and for drawn judges are provided by the organizer at the **Ice rink in the VIP- Room**.

Responsibility: In accordance to **ISU** Regulation, Rule 119, all participants act on their own responsibility. The organizer will provide medical emergency aid during competition.

Calculation of results: Results will be calculated in accordance to I.S.U. Regulation 2004, New System.

Awards: The first three best placed couples in this event will be awarded by special presents, others **with** diplomas.

Registration and Charges: 70,-- EURO per couple. Charge is to be paid for each couple at the registration directly in the **Ice Rink – V.I.P.-Room** before competition.

Draw: November 29th, 2005 at the **Ice rink – V.I.P.-Room**

JUDGES meeting: 12.00 p.m. directly in the **Ice rink – V.I.P.-Room**

<p>Category of Seniors: COMPULSORY DANCES: ISU-Seniors as EM/WM The number of sequences shall be as per Rule 540 para 1. ORIGINAL DANCE: ISU 2005/2006 2 minutes 30 seconds (+/- 10 sec) FREE DANCE : 4 minutes (+/- 10 seconds)</p>

Judges: Each invited Nation which has entered can enter one international Judge, or Judge for I.S.U. Championships.

The organizer reserves the right to select the Judges! Written confirmation will be sent to each nation by **October, 1st 2005**, via fax.

Full board expenses will be covered by the organiser from lunch on **November 29th** until Dinner on **December 2nd, 2005**.

Deadline for entries: All entries (competitors, judges, team leaders, coaches, other attendants) are expected to be mailed recommended and received at the organisers address not later than **October 1st, 2005**. If possible fax entries are appreciated.

Music: Music will be reproduced from cassette player with normal speed or CD. Cassettes or CDs must be labelled with names of competitors, **Member** and category in which they enter. Cassettes or CDs must be delivered immediately after team's arrival to **Organizing Committee**. **Please not MiniDisc (See Rule 343 for wording of**

music reproduction system).

Accommodation: All participants, except drawn Judges, Technicals and Controllers, have to book and to pay the accommodation by themselves. The Hotel AUSTRO TREND is 2 minutes walk distance from the ice rink.

Catering: Meals for all skaters, coaches and for drawn judges are provided by the organiser in **the Ice rink VIP- Room**

Responsibility: In accordance to I.S.U. Regulation, Rule 119, all participants act on their own responsibility. The organiser will provide medical emergency aid during competition.

Calculation of results: Results will be calculated in accordance to I.S.U. Regulation 2004, New-System.

Awards: The first three best placed couples in this event will be awarded by special presents, others by diplomas.

Registration and Charges: per couple 70.-- EURO, Charge is to be paid for each couple at the registration directly in the Ice rink – V.I.P.-Room before competition.
